**NOTE:** On the day of Auction i.e. on 24.7.2013, there will be three separate biddings for the above three lots - (i) Unserviceable items placed at NBRI Stores, (ii) Condemned Ambassador Car at Institute's Campus, and (iii) U/s Items kept at Banthra Research Station - BRS (located nearly 22 kms away from the Institute on Lucknow - Kanpur Road).

### PRIOR INSPECTION:-

- (I) **AT BANTHRA RESEARCH STATION-** On 23.7.2013 between 2:30 PM to 5:30 PM after depositing Caution Money of Rs. 20,000/- (Rupees Twenty Thousand only) strictly per head by DD/Banker's Cheque from a scheduled Bank in favour of 'The Director, NBRI, Lucknow' payable at 'Lucknow'.
- (II) **AT NBRI, LUCKNOW-** On 24.7.2013 between 10:00 AM to 12:00 Noon after depositing Caution Money of Rs. 20,000/- (Rupees Twenty Thousand only) strictly per head by DD/Banker's Cheque from a scheduled Bank in favour of 'The Director, NBRI, Lucknow' payable at 'Lucknow'.

**NOTE:-** Entry will be charged only for once, i.e. any bidder who has submitted a DD/BC of Rs. 20,000/- during his inspection at BRS on 23.7.2013 will not be asked again to submit a fresh DD/BC of Rs. 20,000/- on 24.7.2013 to inspect and attend the Auction at NBRI, Lucknow. These DDs/BCs will be returned to unsuccessful bidders after the Auction is over. In case of successful bidder(s) this amount will be adjusted towards the final payment of the accepted bid price.

### BRIEF TERMS:

1. Only valid Auction Entry pass holders will be allowed to enter in the Auction Hall at 1:30 PM at NBRI Auditorium, Lucknow on 24.7.2013.
2. All sales will be made strictly on "As is where is" basis. In case of vehicle all RTO formalities will be borne by the buyer.
3. The highest bids will be subject to final acceptance of the Scrap Disposal Committee on the spot.
4. The successful buyers will have to deposit EMD @25% immediately on the fall of hammer by cash or Demand Draft in favour of 'The Director, NBRI, Lucknow' payable at Lucknow.
5. The 25% amount will be deposited to State Bank of India, NBRI Branch and the original Challan will be submitted by the bidder.
6. VAT/TCS as per Rules, shall be charged extra by NBRI, Lucknow.
7. The successful buyer(s) will have to deposit balance amount alongwith VAT/TCS within 3 working days and take delivery of the material from Site(s), at their cost & risk, within 10 working days on week days, from the date of Auction, failing which his Earnest Money Deposit shall stand forfeited with NBRI, Lucknow and he will have no claim on the lot or money.
8. In case any bidder is found doing mischief, forming pool/cartel or creating disturbance and/or fails to deposit Earnest Money against his accepted bid, his Caution Money of Rs. 20,000/- will be forfeited with NBRI, Lucknow without prejudice to any other legal and / or administrative action against the miscreants.
