- 1) Item rate e-tender in two envelope systems are invited through the e-tendering portal "<https://etenders.gov.in>" for the work "UPGRADATION OF EXISTING 400kVA TRANSFORMER TO 1000kVA TRANSFORMER AND INSTALLATION OF VCB AND OTHER ALLIED WORKS NEAR PILOT PLANT IN GARDEN" from reputed registered contractors of appropriate class of CPWD, MES, Railways, Post & Telegraph, State PWD's, Semi government organizations or from those who have successfully carried out similar works for CSIR or its laboratories. The tenderers should have successfully completed at least three similar works amounting to 40 % (Rs.11.76 lakhs) or two similar works of 50 % (Rs.14.70 lakhs) or at least one work amounting to 80 % (Rs. 23.52 lakhs) value of the estimated cost or above in a single contract during the last Seven years. Tenders will be issued to **only** those contractors who show the satisfactory work completion certificates, PAN No., Registration under GST (as per rule) in addition to above the firm must complied below list criteria as attached .
- 2) Contractor shall submit audited balance sheet of last 3 years and at least balance sheet of one of the should justify clause no. 1.
- 3) Contracting Agency should have successfully completed SITC job of at least 1 No's 11kV 1 MVA CSS or SITC job of CSS of higher rating in any reputed govt. agency in last 7 years and shall submit completion certificate for the same.
