1. It is hereby notified that the candidates who were found to be eligible on the basis of scrutiny of applications and were shortlisted in accordance with the essential qualification prescribed in the CSIR-NBRI Advertisement No. 02/2024, were invited to appear in the Trade Tests for various posts of *Technical Assistant (Group III)* and *Technician (I) (Group II)*.

6. The Institute reserves the right to cancel candidature at any stage if any information/document is found false, fabricated or not in conformity with the prescribed rules.
