- 2. Candidates must bring originals of the following certificates/documents along with the self-attested copies thereof at the time of Trade Test failing which they will not be allowed to appear in Trade Test:
 - o Matriculation or equivalent certificate as proof of date of birth
 - o Certificates in support of educational qualifications
 - Experience certificate(s), wherever applicable
 - Caste/ EWS certificate (if applicable) in the prescribed format of Government of India issued by the competent authority
 - o No Objection Certificate (NOC) if currently employed in Government/PSU
 - One recent passport-size colour photograph (preferably the same as uploaded with the application)
 - Valid Photo ID proof issued by Central/State Government
 - o Any other relevant certificate supporting the claim made in the application

3. General Guidelines:

- o No TA/DA will be paid for attending the Trade Test.
- Smoking, chewing tobacco or any intoxicants are strictly prohibited in the Examination Hall.

- No request for change in time, date, or examination centre will be entertained under any circumstances.
