### 1). Capacity Building Programmes

A robust training system for employees is important for any organization to succeed in its objective and functioning. The Commission intends to focus on capacity building of employees on key aspects of Preventive Vigilance. A list of topics to be included under these training is as below:

- i. Ethics and Governance
- ii. Conduct Rules
- iii. Systems and procedures of organization
- iv. Cyber hygiene and security
- v. Procurement

In view of above all the CSIR labs will organize training programme for all employees in phased manner, if required, on above-mentioned topics at S.No. ii) Conduct Rules, iii.) Systems and procedures of organization & v.) Procurement at their own level and the topics mentioned at S. No.i) Ethics and Governance & iv) Cyber hygiene and security will be by CSIR-HRDC. The fresh inductees will be trained at CSIR-HRDC. All the employees of the CSIR labs may be encouraged to attend the above trainings. Record of no. of officials trained during the above trainings may be maintained and the same may be in the report of Vigilance Awareness Week (VAW-2024). All Labs will submit their action plan training by 21.08.2024 to CVO,

## 2). Identification and Implementation of Systemic Improvement Measures

Preventive Vigilance Initiatives are key in taking a proactive approach against the menace of corruption. Towards this goal, more systemic improvement measures may be explored by CSIR Labs for adoption during the campaign period. Data of such new initiatives may be reported to the Vigilance Awareness Week report. Posting of officials on sensitive areas may be dealt as per Vigilance Guide-lines.

### 3). Updation of Circulars/Guidelines/Manuals:

All CSIR Labs may review the existing circulars/delegation of powers/channel of submission in process/Charter adopted and displayed on respective websites of CSIR Labs for updation during the campaign period.

### 4. Dynamic Digital Presence

Citizens/stakeholders visit the website seeking details/ information and therefore all CSIR Labs/CSIR-HQ should be prompt in regular up-dation of their website for greater transparency and better service delivery. The organizations should follow extant Government guidelines on development and maintenance of websites (like GIGW 3.0/RBI,s Master Circular on Customer Service in Banks/Security audit), the following action plan is to be taken up during the campaign period. (All labs website updation plan by 25.08.2024)

- During the campaign period, all organizations must make efforts to ensure that their websites are updated and contain all proper and relevant information.
- ii. During the campaign period, all organizations to identify such areas/ activities which can be brought on their existing website and necessary action taken from the same. Identification of above areas will be completed by all Labs/Instts./Units and the same will be informed to CVO,CSIR by 25.08.2024.

In addition to above 5 Preventive Vigilance Areas, Awareness activities- Essay writing, drawing competition, elocution contests, slogan writing, awareness in schools, labs contests & gram sabha, Nukkad Natak etc. and Use of social media for propagation of awareness has to be organized during VAW-2024.

Directors/Heads of CSIR National Labs/Institutes/Centers may be requested to organize the above activities with full enthusiasm. Action taken report on all the activities may be furnished in the prescribed format as mention in annexure-"A"(S.No.1 to 5) of the CVC Circular by 10.11.2024.
