



Keeping in view of observation of CSIR-RAB vide their e-mail dated 11.01.2019, the meeting of the Screening Committee was convened on 02.04.2019 to revise/review recommendations/ Proceedings of the Screening Committee meeting, which was held on 28.07.2018, for one post of Scientist / Senior Scientist, Unreserved, (post code S-01) in the area of Plant Biotechnology (Tissue Culture) against Advertisement No. 02/2017.
