The payment for submitting objections must be made to the account of the Director, NBRI, Lucknow [Account No.: 30267652846 Bank name : SBI, IFSC : SBIN0010173 / Br. Code 10173], through any of the following modes of e-payment : UPI, Online Banking, IMPS, NEFT etc.


Upon making the payment, candidates are required to send detailed objection / challenge in the format prescribed at *Annexure-I*, alongwith a receipt / proof of the payment made against each challenge, to the email address sorectt-nbri@nbri.res.in, within a period of 10 days from the date of publication of this notice.

It is clarified that any objection(s) received through alternate communication channels or modes, shall not be entertained under any circumstances. Only objections submitted in the prescribed format, accompanied by the payment receipt, within the specified period, will be considered valid and taken into consideration.

If the challenge(s) made by the candidate is found correct, the Answer Key will be revised and applied in the response of all the candidates accordingly. Based on the revised Final Answer Keys, the result will be prepared and declared. No individual candidate will be informed about the acceptance/non-acceptance of his/her challenge. The Keys finalized by the Experts after the settlement of the challenge will be final.

In the event that no objection is submitted within the prescribed time limit, it shall be conclusively deemed and presumed that the candidates accept the provisional answer keys as final and binding. Furthermore, by the expiration of the specified period, it shall be presumed that the candidates have no further concerns, objections or disputes regarding provisional answer keys, and they forgo any right to challenge or raise objections to the same beyond the stipulated period.

The decision of the Competent Authority, CSIR-NBRI on such objections/challenges will be final and binding in this regard.
