NOTICE



Considering the documentary evidence attached with an application form, it was observed that the candidate does not possess the accountancy subject in 10+2 examination, which is an essential advertised qualification for the post code A-02. Accordingly, the candidate does not possess the EQ for the post code A-02. Therefore, his candidature for the post code A-02 is not admissible. Hence, the representation of concerned candidate is hereby disposed off accordingly.

Hence, the representation of concerned candidate is hereby disposed off accordingly.
